Municipal Annexation Plan

COUNTY OF CAMERON

WHEREAS, after a thorough study having been made and as required by Chapter 43, Local Government Code, the city of Harlingen intends to amend the Municipal Annexation Plan adopted by Resolution #01-58 on December 19, 2001 by deleting all parcels identified as annexations that may occur beginning on third anniversary of the original Plan was adopted; now therefore

BE IT RESOLVED BY THE CITY OF HARLINGEN:

That the Municipal Annexation Plan 2001 identified the following tracts of land that could be annexed beginning on the third anniversary of the date the original Resolution was passed and now deletes these four tracts from the annexation plan:

TRACT 1: Las Palmas/Country Club Estates parcel including all of Block 2 of Harlingen Land & Water Co. Subdivision "C"; remainder tract of the east 1/2 of Survey 299 north of the projected line at Kroeger Road; all of V.W. Subdivision; all of Country Club Estates Subdivision; all of Myerwood Subdivision #1; all of Myerwood Subdivision #2; 1.0 acre tract of land out of the northeast corner of Block 14, Harlingen Land & Water Co. Subdivision "C"; all of Las Palmas Subdivision #1; all of Las Palmas Subdivision #2; all of Las Palmas Subdivision #3; all of Block 13, Harlingen Land & Water Co. Subdivision "C"; remainder northeast of Block 1, Harlingen Land & Water Co. Subdivision "C".

TRACT 2: Graham Road parcel including all of Nesmith Subdivision; remainder tract of land out of Blocks 27-35 out of Part of Stuart Place Showing the Resubdivision of the south part of Section No. 137 and the north part of Section No. 297; remainder tract out of Blocks 19-21 of Stuart Place Resubdivision of parts of Sections 297 and 137; all of Gaston-Johnson Subdivision; all of Western Subdivision; remainder of north 1/2 of Lot J of Stuart Place Subdivision; remainder of south 1/2 of Lot L of Stuart Place Subdivision; all of Milton Subdivision; all of Christine Subdivision; all of Lewis Subdivision; all of Puesta Del Sol Subdivision; all of Raul Lerma Subdivision; all of Autumnwood Subdivision; all of Eduardo Muniz Subdivision.

TRACT 3: Los Juarez parcel including remainder part of Blocks 17 and 18, all of Block 25, remainder of Block 26, north part of Block 27, all of Block 28, and all of Block 35 of the Petersburg Syndicate Subdivision; all of Juarez Subdivision; all of Fred Adams Subdivision; all of Dora E. Shady Park Subdivision; all of Cruz Subdivision; all of Strickland Subdivision.

TRACT 4: Teege Road parcel including remainder tract of the east ½ of Survey 299 south of the projected line at Kroeger Road; all of Zamora Estates Subdivision; Lots 1-8 of the Subdivision of Northern Part of Survey 137; all of O.P. Storm's Subdivision out of Survey 137; all of Daralo Subdivision; all of Lynville Subdivision; all of El Pasillo Unit #1 Subdivision; all of Leisure Estates Subdivision; all of Chester Park Subdivision; all of Las Palmas Subdivision Unit No. 4; remainder tract of Block 15 and all of Block 16, Harlingen Land & Water Co. Subdivision "C"

It is hereby noted that these four parcels shall not again be eligible to be placed on a Municipal Annexation Plan for involuntary annexation prior to two years from the date of the passage of this resolution.
