Mayor Boswell called the meeting to order; a quorum was established. A notice of the meeting was duly posted according to state law. The following proceedings were held.

Commissioner Tudor Uhlhorn gave the invocation.

Mayor Boswell led the Pledge of Allegiance and welcomed everyone in attendance.

ORDINANCE NO. 13-38

AN ORDINANCE AMENDING THE REVENUE AND EXPENDITURES BUDGET FOR THE CITY OF HARLINGEN, TEXAS, FOR THE FISCAL YEAR OCTOBER 1, 2012 THROUGH SEPTEMBER 30, 2013. BUDGET REVENUES WILL DECREASE TO \$66,027,034 AND TOTAL BUDGET EXPENDITURES WILL DECREASE TO \$66,338,753 RESPECTIVELY; PROVIDING FOR PUBLICATION OF THE CAPTION OF THIS ORDINANCE AND ORDAINING OTHER MATTERS RELATED TO THE FOREGOING.

5) Consider and discuss an ordinance authoring the issuance of the City of Harlingen, Texas General Obligation refunding bonds, Series 2013, approving and authorizing the execution of an escrow agreement, a paying agent/registrar agreement, a purchaser contract and other instruments and procedures related thereto, delegating and authorizing the Mayor or the City Manager to select outstanding bonds to be refunded and approve all final terms of the bonds, approving an official statement, and calling certain bonds for redemption.

Anne Burger Entrekin, Managing Director with First Southwest Company gave a PowerPoint presentation of the City of Harlingen refunding opportunities. They would frequently monitor the City's outstanding debts for refunding opportunities. They would provide information to the City on the refunding analysis and various components used to analyze and determine the best time to move forward. She highlighted the Market Update and Refunding Analysis with Considerations; Bond Buyer's Index of 20 Municipal Bond; Credit Interest Rate Spread to AAA - MMD; AAA-MMD Yield Comparisons; Potential Refunding Candidates; Partial Non Advance Refund of Series 2005 Bonds; Proposed: Current Refunding of Series 2005 Bonds; Current Refunding of Series 2005 Bonds; Qualified Tax Exempt Obligation (QTEO) or Bank Qualified (BG) Proposed Calendar of Events; and Refunding Considerations.

Discussion was held regarding the refunding of Series 2013 Bonds and interest rates and Ms. Entrekin stated the interest rates had risen to 100 basis points over the last couple of months and about 167 basis points back in December of 2012. The current environment rate was high than it was at other times. From a historical prospective the interest rate environment was low. If the City authorized the transaction on the refunding of the bonds the closing date had to be done within 90 days from the call date which was February 15, 2014 and allow for bonds to be sold and closed.

6) Consider and take action to adopt a resolution authorizing the submission by the Police Department for funding of the 2014 Selective Traffic Enforcement Program (S.T.E.P.) Comprehensive Grant through the Texas Department of Transportation (TXDOT).

Tom Whitten, Police Chief stated approval of the resolution was required by the City Commission to authorize the Harlingen Police Department to submit a grant application to the Texas Department of Transportation for approximately \$86,000. The purpose of the funding if approve, would provide for off duty/overtime capacity which would not affect on duty staff and be able to enforce the S.T.E.P. Program.

Motion was made by Commissioner Leal and seconded by Mayor Pro-Tem Castillo to approve and adopt the resolution as presented. Motion carried unanimously.

7) Consider and take action to approve Contract Number 2014-044165-001 for services between the Department of State Health Services (DSHS) and the City of Harlingen Vital Statistics Department to utilize the DSHS Remote Birth Card Database for birth records of citizens born outside of Harlingen, but within the State of Texas.

Ramiro Gonzalez, Health Director recommended the renewal of the DSHS Remote Birth Card Database Contract with the State Health Department. The new contact would commence September 1, 2013 and expire August 30, 2015.

Motion was made by Commissioner Uhlhorn and seconded by Mayor Pro-Tem Castillo to approve the contract between the City of Harlingen and the Department of State Health Service. Motion carried unanimously.

8) <u>Consider and take action to amend Ordinance No. 98-58 to establish "School Zones" along Jefferson Avenue, 6th Street and 7th Street for Harlingen Christian Academy School located at 622 W. Jefferson.</u>

Javier M. Zamora, City Engineer stated the Harlingen Christian Academy, located at 622 Jefferson Avenue was requesting school zone signs on Jefferson Avenue west of the intersection of 6th Street, 7th Street between Jefferson Avenue and Madison Avenue, 6th Street north of Madison Avenue and 6th Street north of the intersection of Jefferson Avenue. This would provide for a 20 mile per hour speed limit for pickup/drop off times during school hours. He recommended approval of the school zones for the new Harlingen Christian Academy.

Richard Bilbie, Interim City Attorney read the caption of the ordinance.

Motion was made by Commissioner Sanchez and seconded by Commissioner Mezmar to approve and adopt the ordinance. Motion carried unanimously.

9) <u>Consider and take action to approve a resolution adopting the Development Corporation of Harlingen, Inc. 2013-2014 Fiscal Year Budget.</u>

Raudel Garza, Executive Director of the Harlingen Economic Development Corporation (EDC) of Harlingen, Inc., stated the EDC finalized the budget which consisted of the following: total revenues - \$6,169,598.00 that included the following expenditures: Total Operations - \$925,000; Contracts - \$278,700; Projects - \$4,965,898.00. He recommended approval of resolution.

Motion was made by Commissioner Uhlhorn and seconded by Mayor Pro-Tem Castillo to approve the resolution adopting the EDC Fiscal Year Budget for 2013-2014. Motion carried unanimously.

Motion was made by Commissioner Mezmar and seconded by Commissioner Leal to approve the board appointments. Motion carried unanimously.

11) Citizens Communication

Ramiro Villarreal, Route 1 Box 27, corner of Primera Rd. & Highway 77 stated he had several issues with the City. He reported three police officers and Code Enforcement Officers had visited his residence while he was at an appointment and his mother kindly requested that they come back. He also reported Ms.Elida Mendoza, Code Enforcement Officer proceeded to open a door that was closed and after their investigation never closed the door. He presented seventeen pictures to the City Commission that he took of other areas that needed to be addressed. Mr. Villarreal stated the officers had nicked named his property as the city dump and felt that the City staff was always hounding him.

Mayor Boswell said he would direct staff to look into Mr. Villarreal's issue.

Joe Rubio, 2309 Hacienda Road recognized Emma Trevino, Valley Morning Star Reporter for exposing the nonsense of the Blaschka Towers. He did not understand what gave the Mayor the authority to spend \$4 million on this project. Mr. Rubio questioned if there was a consensus of the Commission to spend millions of dollars to fix a building that was worthless. He hoped that the item be placed on the agenda for reconsideration. Mr. Rubio referred to the demotion of Captain Luciano Rubio and stated it had come to his attention that former Commissioners had rode around with the newly hired assistant police chief which was in violation of the Harlingen Police Department and Civil Service regulations. He hoped the Commission would take this into consideration that Captain Rubio was a company man and has demonstrated his ability to do so.

Regular CC Mtg 9/18/2013

Frances De Leon, 520 N. Commerce agreed with the comments made by Mr. Rubio in regards to the Blaschka Tower. She said no matter who spoke in regards to this issue the City Commission continued to make decisions on the Blaschka Tower. Ms. De Leon stated that this building was being purchase so that Ms. Jo Wagner would get the contract on this project. There were many contractors around the community that could use the money also. A petition was being circulating in opposition of the project.

There being no further business to discuss, the meeting adjourned.
