## 2) Consider and take action to approve incentive agreement with Project Ring.

Raudel Garza, CEO for the EDC stated discussions were held with the EDC board members and the City Commission in regards to Project Ring (Qualfon Data Service Group) a proposed Customer Contact Center to locate at 2200 Haine Drive. Qualfon would be employing approximately 227 people the first year of which 27 would be in the IT, Management Department. After the first year, an additional 200 people would be hire and possibly the amount of employees would increase after the third year. The incentive proposal offered to Qualfon Data Service Group was favorable to both parties. Mr. Garza welcomed Victor Garcia and Kevin Kavanaugh, company representatives.

Mr. Garcia stated their company was established in 1996 and has been successful because it was driven by values empowering people's life and helping the communities. He presented a video of the insights and views of their company. They were extremely excited to be in Harlingen. It had been a long journey in choosing Harlingen as their next location because of the customer service offered from the labor pool of the people in the Rio Grande Valley. It would be one of the most successful operations.

Mayor Boswell stated he was excited that Qualfon Data Service Group chose Harlingen for its newest operation as well as being part of their global family. With the possible creation of 400 new jobs it would be another great day in Harlingen. He congratulated them and thanked Mr. Garza and EDC board members for making this project a reality.

Dr. Leal welcomed Mr. Garcia and announced that the word he heard often from the presentation made was "Teamwork." He extended the City and EDC's support and wished them great success in their new endeavor.
