Mayor Boswell called the meeting to order and a quorum was established. Notice of the meeting was duly posted according to state law. The following proceedings were held.

Commissioner Leal gave the invocation.

Mayor Boswell led the Pledge of Allegiance and welcomed those in attendance.

Carlos Yerena, City Manager thanked Jeff Lyssy, Parks Superintendent, his kids and Parks Department employees for assisting after the Cinco De Mayo Celebration. He reported on the Community-Wide Trash-Off Day held May 24, 2014 and stated 13.26 tons of debris and 140 tires were collected. He thanked members of La Luz de Mundo Church, Cameron County Juvenile Justice Department for volunteering their services in this event. The next Community Trash Off-Day was scheduled for August 23, 2014.

Mr. Yerena and Commissioner Leal presented Certificates of Appreciation to members of La Luz de Mundo Church, Tamayo Home for Boys and Cameron County Juvenile Justice Department for participating in the Community Trash-Off Day. Motion was made by Commissioner Uhlhorn and seconded by Commissioner Leal to approve both sets of minutes as presented. Motion carried unanimously.

## **CONSENT AGENDA**

Consider and take action to approve the final plat of Woodland Oaks Subdivision Phase I, 6) being 15.798± acres with 2.690 acres out of Block 4 and 5.096 acres out of Block 5, Stuart Place Subdivision of Survey 138 and 8.012 acres out of Reserve Lot, Stuart Place Section I & Reserve, generally located along the north side of Queen Sago Road between Beckham Road and North Taos Drive.

Motion was made by Commissioner Mezmar and seconded by Mayor Pro-Tem Castillo to approve the item under the consent agenda. Motion carried unanimously.

7) Public Hearing and take action to approve the One Year Action Plan (Budget) for Fiscal Year 2014-2015 (Year 40) of the Community Development Block Grant (CDBG) Program and Fiscal Year 2014-2015 (Year 20) of the Home Investment Partnerships Program (HOME).

Tammy DeGannes, Community Development Director made a power point presentation on the allocations for the proposed One Year Action Plan Budget. The Community Development Advisory Board met six times to review the applications received for funding totaling \$3.5 million. The board cut \$2.5 million and arrived at the following recommendations.

Commissioner Mezmar inquired if the federal government continued to allocate less funding.

Ms. DeGannes responded yes. This year the CDBG received \$26,000 less.

## Public Hearing

Mayor Boswell announced this was a public hearing and anyone wishing to speak for or against the item could do so.

There being no comments, Mayor Boswell declared the public hearing closed.

Mayor Boswell thanked and gave special recognition to the CDBG Board members for their hard work in making decisions regarding the allocation of funds to the different projects and organizations. He was pleased that C.B. Wood Park was allocated some funding.

Motion was made by Commissioner Sanchez and seconded by Mayor Pro-Tem Castillo to approve the One Year Action Plan for Fiscal Year 2014-2015. Motion carried unanimously.

8) Consider and take action to authorize the Community Development Director to negotiate the price for Aquatic Engineering Design and Construction Management Services for the Lon C. Hill Pool Renovation Project with the most qualified firm, The Brannon Corporation and authorize the City Manager to execute the contract after negotiation of price.

Ms. DeGannes stated thirty five engineering firms were notified of the request. Two firms submitted statement of qualifications for consideration. Staff evaluated statement of qualification and requested permission to negotiate a contract with the Brannon Corporation for the renovations at Lon C. Hill Pool.

Commissioner Mezmar stated he received numerous calls and complaints about the quality of the pool. The renovations were long overdue.

Motion was made Commissioner Uhlhorn and seconded by Commissioner Leal to authorize the CDBG Director to negotiate the price for Aquatic Engineering Design and Construction Management Services with The Brannon Corporation for Lon C. Hill Pool and authorize the City Manager to execute the contract. Motion carried unanimously.

9) Consider and take action to approve an ordinance on first reading to amend the City of Harlingen's budget for fiscal year 2013-2014.

Elvia Trevino, Finance Director stated the amendments were required to account for grants that were awarded after the fiscal year ended. She stated "Exhibit A" listed all fund budget revenues and expenditures which were as follows:
