SEARCH WARRANT



On 3-31-2016, The Harlingen Police Department Major Crimes Unit, along with the Criminal Investigations Division, Organized Crime Unit, and SWAT, conducted a search warrant at the 1200 block of North Bus. 77. Investigators had obtained a search warrant for the residence in reference to an Aggravated Robbery that had occurred during the early morning hours. The robbery occurred on the 600 block of W. Harrison Avenue at approximately 2:30am. During the robbery, the suspects displayed weapons(s) and assaulted two victims. During the execution of the search warrant, evidence was located and seized, which included firearms, and narcotics. Four subjects have been placed into custody at this time. The investigation is ongoing.
