At approximately 9:53am on February 8, 2019, Uniformed Harlingen Police Officers responded to a residence of the 300 block of Lozano Street in Harlingen, Texas in reference to an assault. Upon arrival Officers located two victims inside the residence (an adult male and an adult female). Investigation revealed that several subjects had entered the residence without consent and assaulted both victims with an unknown object. Both victims sustained injuries and were transported to a local hospital for treatment. The suspects were reported to have fled the area in a brown older model Oldsmobile passenger vehicle. Two adult suspects (identified as **Luis Humberto Rojas** and **Josefina Dinorah Simental**) have been arrested for their suspected involvement in the crime. Investigators have identified a third subject (**Carlos Estrada**) and have secured a Felony warrant for his arrest. This crime remains under investigation.
