INDECENT EXPOSURE

At approximately 9:48am on July 10, 2016, Uniformed Harlingen Police Officers responded to the Hugh Ramsey Park (1000 S. Loop 499) in reference to male subject exposing himself in a public place. The victim (an adult male Harlingen resident) reported that the male suspect assaulted him when confronted and advised that the police had been notified. The male suspect fled the area in a black Pontiac G-5 (license plate information provided by witness). A responding Police Officer located the suspect vehicle on Sam Houston Blvd. and attempted to stop said vehicle. The operator of the vehicle refused to stop and evaded police. The Officer terminated his pursuit of the suspect vehicle over safety concerns to the general public. The suspect vehicle was last seen traveling South on Ed Carey Drive. Through the course of the investigation, the male suspect was identified as **Leobaldo Zuniga Jr.** and an arrest warrant was obtained. Zuniga voluntarily turned himself into the Harlingen Police Department on July 12, 2016. Zuniga is being charged with the following offense; **Indecent Exposure** – Class B Misdemeanor, **Assault** - Class A Misdemeanor, and **Evading Arrest / Detention W/ Vehicle** – State Jail Felony.
