At approximately 2:18am on May 30, 2015, Uniformed Harlingen Police Officers responded to the 800 block of North 26th Street regarding an assault. Upon arrival on location, the Officers made contact with multiple subjects. One subject, an adult male subject was bleeding from a stab wound to his torso area and was transported to the hospital for treatment. Through the course of the Investigation, three subjects were ultimately placed under arrest for Aggravated Assault. The subjects were identified as Ricardo Walter Jr, Jessica Marie Padilla, and a 15 year old male juvenile. All three subjects were transported to the Harlingen Police Department for processing. While processing the crime scene, Investigators located and seized 87 grams of marijuana. Jessica Marie Padilla and a second female subject (identified as Crystal Ann Longoria) were additionally charged with possession of marijuana. Walter also faced an additional charge of Fail to Identify after initially providing the investigating Officers with a false name. The juvenile male subject was transported and detained at the Darrell Hester Juvenile Detention Center.

The Harlingen Police Department takes all incidents of Violence very seriously and investigates fully in order to protect the victim and other affected parties. Anyone who witnesses or is aware of acts of violence is encouraged to call their local law enforcement agency or any other agency equipped to assist victims of violence.
