At approximately 2:30am on June 22, 2015, Uniformed Harlingen Police Officers were investigating an incident of criminal mischief that had occurred in the Hot Shots Bar parking lot (640 N. Ed Carey Drive). The Investigation led the officers to the 4800 block of S. Expressway 77 (Texas Road House), where contact was made with five male subjects standing around a Tan Chevrolet Silverado pick-up. During the contact, the Officers determined that four of the subjects were intoxicated and discovered several open containers of alcohol in the area. During the investigation, the Officers located and seized 0.3 grams of cocaine and 1.8 grams of marijuana. All five subjects were placed under arrest and transported to the City Jail for processing. The drugs were tagged and secured as Evidence. All five subjects were employees of the Texas Roadhouse and were found intoxicated and in possession of narcotics while on the premises and were additionally charged with Lewd, Immoral, Indecent Conduct.
