At approximately 8:06pm on June 25, 2015, a Uniformed Harlingen Police stopped a White 2005 Jaguar on the 1400 block of Summerfield Lane for reversing against traffic and nearly colliding with another vehicle. Contact was made with the female driver, who initially provided the Officer with a fictitious name. Investigation revealed the subject's true identity (Pamela Ester Diaz), and a records check revealed several outstanding warrants. Diaz was placed under arrest and transported to the City Jail for processing. During booking procedures, Diaz was found in possession of marijuana (5.0 grams) and a controlled substance (1.0 grams of Alprazolam).
