CITIZEN PARTICIPATION PLAN AMENDMENT

This notice is intended to provide general information to the public on proposed amendments to the City of Harlingen's Citizen Participation Plan (CPP). The proposed CPP is available for public review during regular business hours at the Community Development Department, 502 E. Tyler, Harlingen, Texas, and may also be accessed on the City's website at www.myharlingen.us.

The City of Harlingen (City) is an Entitlement City in the U.S. Department of Housing and Urban Development's (HUD) Community Development Block Grant (CDBG) Program. As such, the City must have a Citizen Participation Plan that provides for and encourages public participation, emphasizing involvement by low and moderate income people-especially those living in low and moderate income neighborhoods. The changes to the City's current CPP are required as per 24 CFR 91.105 which includes new language to incorporate 24 CFR Part 5 (Affirmatively Furthering Fair Housing).
